## Under New Agreement, Montgomery Public Schools Will Work to Provide Better Services to Children with Mental Illnesses

Montgomery, AL – November 28, 2011 – Under a settlement agreement announced today that resolves complaints filed on behalf of Montgomery families by the Alabama Disabilities Advocacy Program (ADAP), the Judge David L. Bazelon Center for Mental Health Law, and the Law Offices of Sears & Sears, PC, the Montgomery Public Schools will take significant steps to provide more effective services to students with emotional disturbance.

Under the agreement, Montgomery Public Schools (MPS) will hire a nationally-known expert in children's mental health, Narell Joyner of Charlotte, North Carolina, to work with MPS teachers and administrative staff to evaluate how MPS identifies and plans for students with emotional disturbance, and to identify available resources MPS can access to better serve these students. Ms. Joyner will also make recommendations for how MPS might improve and fund its programs serving students with emotional disturbance, and help MPS implement her recommendations.

"There are hundreds of Montgomery students with disabilities who need some additional help to reach their academic potential and lead independent and successful lives in their communities," stated James Tucker, legal director for ADAP, lead counsel for the parents who filed complaints against MPS. "We think Montgomery Public Schools can do an excellent job of educating these students, and Narell Joyner is just the person to help get the schools to where they need to be."

The parents' complaints, which were filed in May with the Alabama State Department of Education, alleged that MPS systemically failed to identify, and provide mental health services to, children with emotional disturbance in violation of federal and state civil rights laws. Instead, MPS often punishes these students for conduct related to their disabilities and pushes them out to "alternative schools" or to the juvenile justice system.

"We're so happy that MPS has taken this opportunity to work with us to improve how it serves students with emotional disturbance," said ADAP Attorney Nancy Anderson. "When schools work with families to figure out what kids need to succeed, everyone wins."

The families' advocacy efforts were also assisted by Schulte Roth & Zabel LLP, which, as part of its pro bono legal program, worked with ADAP and the Bazelon Center for Mental Health Law to pursue the relief achieved in the settlement agreement. "Schulte Roth & Zabel is pleased to partner with the Bazelon Center on its mission of advancing policy to aid people with mental disabilities," said Howard Schiffman, a partner in Schulte Roth & Zabel's Washington, D.C., office and co-chair of the firm's Litigation Group. "We are hopeful that this agreement will help enable MPS both to improve the education and prospects of children with mental illnesses in Montgomery and also to serve as an example of effective education services for school districts nationwide."
