#### **Capitol Hill Update**

We continue to push back against the Graham-Cassidy healthcare bill and are pleased to announce that state-specific fact sheets on the proposal are now available on our website: http://www.bazelon.org/our-work/advocacy/#states.

As you may have heard, Senator John McCain (R-AZ) has announced that he cannot support the bill. In addition, Senator Rand Paul (R-KY) has indicated he will not support the bill and Senator Susan Collins (R-ME) said that she is leaning no on the bill. Nothing is over until September 30th when the legislative tool being used to try and pass the bill with only 50 votes expires, but our efforts are starting to work again! PLEASE KEEP UP THE PRESSURE!

Please go through the regular formal process of submitting statements for the record, detailed below. In addition to mailing your organization's statement to the Committee, you can submit it electronically to the Ranking Member by emailing a copy to kevin\_wright@finance.senate.gov.

Any individual or organization wanting to present their views for inclusion in the hearing record should submit a typewritten, single-spaced statement, not exceeding 10 pages in

length. Title and date of the hearing, and the full name and address of the individual or organization must appear on the first page of the statement. Statements must be received no later than two weeks following the conclusion of the hearing. Statements should be mailed (not faxed) to:
