THE LITIGATION GENERALLY USES AND IS FOUNDED UPON LAWS THAT PROTECT AND BENEFIT PEOPLE WITH DISABILITIES, INCLUDING AMONG OTHERS THE AMERICANS WITH DISABILITIES ACT (EQUALITY OF OPPORTUNITY), THE INDIVIDUALS WITH DISABILITIES EDUCATION ACT (SPECIAL EDUCATION), AND THE MEDICAID ACT (HEALTH AND MENTAL HEALTH CARE). THE BAZELON CENTER'S STAFF PROMOTE THESE GOALS IN FEDERAL LEGISLATION AND REGULATION, POLICY ANALYSIS AND RESEARCH AND GRASSROOTS ADVOCACY. RECENTLY, THE BAZELON CENTER'S POLICY ADVOCACY HAS FOCUSED ON EXPANDING COMMUNITY-BASED MENTAL HEALTH SERVICES, DIVERTING PEOPLE WITH MENTAL DISABILITIES FROM THE CRIMINAL JUSTICE SYSTEM, INCREASING THE SUPPLY OF AFFORDABLE HOUSING, PROTECTING UNACCOMPANIED MINORS, AND TECHNOLOGY AND AI.
